### **Notes about the Fee and Financial Assistance**

The fee is HK\$900 per person. Financial assistance scheme is available for needy students. The details are shown below

1. Eligibility – be successful in his/her application for financial assistance under the Comprehensive Social Security Assistance (CSSA) Scheme OR Senior Secondary Fee Remission Scheme OR School Textbook Assistance Scheme
2. If the applicant's family is receiving CSSA, applicant should provide the Certificate of CSSA recipients and the notification letter as supporting documents.
  - If the applicant is receiving senior secondary fee remission, applicant should provide the notification letter from the secondary school as supporting documents. In addition, the name of the applicant and the amount of assistance (i.e. full rate/half rate) should be stated in the letter.
  - If the applicant is receiving textbook assistance, applicant should provide the notification letter from the secondary school as supporting documents. In addition, the name of the applicant and the amount of assistance (i.e. full rate/half rate) should be stated in the letter.
3. Successful applicants will be notified via phone on or before **14 July 2008**.
4. The amount of assistance will not exceed HK\$500.

### **Notes for Applicants**

1. Student applicants must get parent's approval and signature in applying for the activity.
2. Students should check the above website on the day. No further notification will be sent.
3. EDB and the course organizers will do their utmost to ensure the safety of the student participants during the activities. Nevertheless, parents have the responsibility to decide whether the programme fits their children according to the situation of their children and the nature of the programme, and bear all the consequences. To ensure safety, parents must decide whether it is necessary to arrange to send their children to the venue of the activities and pick them up after the activities.
